Membership Report

At the end of December 2018, STTC had:

Total Members 127 Paid Memberships 108 Individual 90 Family 11 Seasonal 7 Non-paying 17 Juniors 5 Basic Membership donations collected \$3.685 extra donations \$145

In 2018 we had 2 fewer memberships than 2017, however there are at least 3 that have promised to pay, but due to holiday, have not seen to collect. Membership seems stable at around 130.

Officers, Club Managers, and ABBS have the option of free Basic Membership.

The recent low count for members was 72 in 2014. The high was146 in 2016.

Funding was approved for \$540 for 2018. \$140 was unused.

4 sessions. Only 3 sessions came out of this year's budget. Between 10 and 18 participated in each session.

4 sessions per year seems to be the ideal number for participants, Coach and Long Center availability.

I recommend starting an evening Clinic for those members who work, however, we would need a volunteer to coordinate it and for Coach to have the availability.
